INDIAN TRANSLATION COMMUNITY GATHERS IN NEW DELHI

Translators, interpreters and other language professionals from all over India gathered in New Delhi from 16-18 April 2009 for the **National Conference on "Language and Translation Industry of India: Opportunities & Challenges".** The conference and preceding workshop were the first of their kind in the region.

The warm-up activity to the conference began on 16 April 2009 with a **pre-conference workshop** dedicated to **Quality Standards, Terminology Management, Professional Practices and CAT Tools**. The workshop was hosted at the Instituto Cervantes and inaugurated by His Excellency Miguel Angel Ramirez Ramos, Ambassador of Cuba in India. He emphasized the need to create awareness about quality standards, terminology management, professional practices and CAT tools in translation.

More than 150 participants attended the workshop. Experts of international repute included Prof. Roger T. Bell (University of Westminster, UK) who brought afternoon alive through his sessions on *Professional Practices in Translation*. The sessions were then continued by experts from Austria: Dr. Gabriele Sauberer (TERMNET) shared her knowledge on *Terminology Management and Quality Standards in Translation*; Dr. Peter Jonas (LICS) explained the *EN 15038 standard*; Ms. Anja Drame (INFOTERM) dealt with International *standardization for terminology and other language and content resources*. The workshop ended with an exclusive session on *CAT tools* by the conference convener Mr. Ravi Kumar who emphasized the need to integrate with the translation technology. This was followed by a demonstration of a newly developed *CAT tool called "Heartsome": a new generation cost effective CAT tool that fully supports Indian languages*.



Those of you who were not able to attend and those who would like to read more about the topics presented in New Delhi need not worry. Translation Industry INDLA S BOOMING MARKET IN CHANGE

India's translation industry is booming, especially due to the presence of global companies in India. Many international companies outsource translation to India, the number of freelance and employed translators is large. This is partly due to low labor cost and a relatively high knowledge of the English language. Most translation jobs handled by Indians therefore is from other European languages into English. Education, training and status of the translation professional in India do not match or even reflect this situation. Awareness of quality is still low among professionals who, still, often are bilinguals without professional education in translation.

The Indian translation industry is at present in a rapid process of change. Especially since the foundation of the first real national Indian Translators Association and their efforts to network nationally and internationally and raise awareness locally a new air of growing self-awareness has been taking place in the country. More and more European clients demand not just cheap translations but also compliance with quality standards like the EN 15038. And it has to do so: Its greatest competitor, China, is catching up fast.



But another development is also noteworthy. India increasingly discovers her own potential as a consumer market, where translation means also translation into the local Indian languages. Universities are dedicated to create curricula for translators and interpreters.

DID YOU KNOW?

There are hundreds of languages in India. Numbers and statistics vary From ca. 114 to more than 1000.

Most of the languages belong to the Indo-European, Dravidian, Tibeto-Burman or Austro-Asiatic language families.

As per constitution, Hindi is the official language of the Indian Union. English was intended to be used for 15 years after in order to assist the transition from the language of the colonial power to an indigenous medium. However, due to growing concern from the large number of non-Hindi speaking communities it was decided by act in 1963 to continue the use of English along with Hindi for official purposes.

Indian states specify their own official language(s) through legislation and state borders like Tamil Nadu had to be re-drawn analogous with linguistic borders.

Legal framework governing the use of languages for official purpose:

- Constitution,
- Official Languages Act of 1963,
- Official Languages (Use for Official Purpose of the Union) Rules of 1976,
- various state laws, rules and regulations made by the central government and the states.
